Chuck Rudinsky offered to donate a HIT mast if USAFA agreed to pay for the repairs.

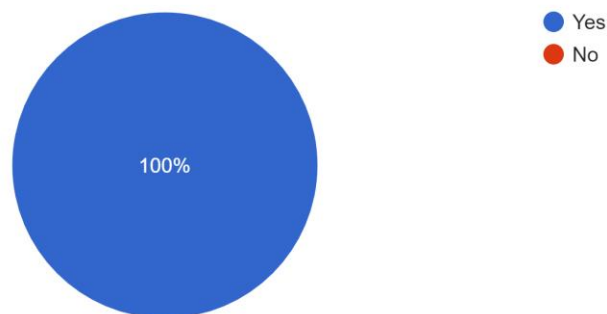
Proposals and Officers election: Vote facilitated by google forms. No votes or motions excepted from the floor. Results are below in the pie chart format.
